Scope & Applicability

EAZYO APP LLC (“EAZYO”) values and respects your privacy. This Privacy Policy (“Policy”) explains how we use and protect the information we may collect from visitors and users of the Sites. Please read these terms and conditions (“Terms”) carefully. This Policy applies only to information collected through this website <http://www.eazyo.com> and any affiliate, subsidiary and future EAZYO affiliate and subsidiary sites, related mobile Sites, mobile applications and domains (collectively referred to as “Sites”). As used in this Agreement, “EAZYO,” “us,” “we,” and “our” shall mean EAZYO APP LLC. It does not apply to information collected off-line, or to any other websites to which a link may be provided as part of our Sites. If you are accessing another website through our Sites, we suggest that you review any and all applicable third-party privacy policies, as EAZYO has no control and is not responsible for the actions of third parties.

By accessing or using the Sites, or any of its services, you consent and agree to the collection, transfer, manipulation, storage, disclosure and other uses of your information as described in this Policy. If you do not agree to these Terms, you may not use, browse or access the Sites, or its services, in any manner.

Information Collection

We may collect both personally identifiable information that uniquely identifies you and anonymous user data when you visit or access our Sites, create or edit an account or make a purchase.

Personal Information

When you create an account, or edit your account information, we may collect personally identifiable information such as your name, address, phone number, email address, username and password, your gender, date of birth and country of origin (“Personal Information”). When you make a purchase through the Sites, we and our third party service providers may collect sensitive Personal Information related to your finances such as your credit card number and/or credit card security number, account information, and information about the date, amount and nature of financial transactions. In addition, in an effort to provide services to you, we may obtain information about your physical location by use of GPS or other geolocation features in your device or through our Sites.

Anonymous User Data

When you access or use the Sites, we, and our third party service providers may collect, store and aggregate anonymous user data that does not personally identify you such as Sites usage details, demographic information, Internet protocol (IP) addresses, the domain name of the Sites providing you with Internet access, browser type and version. We and our third party service providers may also aggregate personally identifiable information in a manner that does not uniquely identify you or any other use of the Sites.

❖ Cookies or other Anonymous Identifiers

EAZYO, our third party service providers and other third parties utilize cookies, pixel tags, web beacons, anonymous identifiers and other technologies to collect usage data and customize our Sites content. The information stored in cookies may be linked to the Personal Information you provide while visiting our Sites.

You have the option to decline cookies on your computer by configuring your

preferences options within your web browser. However, if you choose to decline cookies, some of the functionality of the Sites may be impaired.

❖ **Third Party Analytics Services**

EAZYO utilizes Google Analytics to collect the information sent by your browser as part of a web page request, including cookies and your Internet Protocol (IP) address. Please review Google's Privacy Policy before using our Sites, as it governs the use of this information.

Information Use –see 3

We, and our third party service providers may use and store the Personal Information and anonymous user data that we collect, or that you choose to provide to:

- Perform services at your request (e.g. to enable you to order food, beverages and products through our third party hospitality partners and have it delivered to you);
- Process, or allow third party service providers and affiliates to use the Personal Information for the purposes described herein including, but not limited to, processing your account registration and purchases and to verify your information for accuracy;

- Maintain, customize and enhance performance of the Sites;
- Carry out our obligations and enforce our rights pursuant to our Terms;

- Operate the Sites and our business including conducting data analysis and audits, enhancing our services and identifying usage trends.

Information Sharing & Disclosure

These third party service providers are authorized to use your information only to the extent necessary to serve these purposes, or as otherwise stated in this Policy.

Except as described above, we, or third party providers acting on our behalf, will not sell, trade, or otherwise disclose your Personal Information without your consent except when we believe release is appropriate to comply with the law, enforce our Sites policies, or protect ours, or others rights, property, or safety. However, anonymous user data may be provided to other parties for marketing, advertising, or other uses.

Social Media, Public Forums & Blogs

EAZYO operates a public forum page to allow our users the opportunity to communicate with one another online. We also operate corporate blogs and microblogs. These forums are operated by independent third parties such as Twitter, WordPress, Tumblr, and Pinterest. Any information that you submit on these forums will be governed by their privacy policies. Security

We have taken reasonable precautions to help keep your Personal Information secure and confidential.
